- 3. Please inform the Ottawa Food Bank once the transfer has been completed. Unexpected and/or unidentifiable transfers may make it difficult for us to issue the donation receipt in a timely manner.

Please Note:

- 1. In accordance with our Board Policy, securities will be sold as soon as possible.
- 2. Under current tax regulations, your donation of publicly traded securities is exempt from capital gains tax only when you transfer the securities *in-specie* or in-kind to a charity.
- 3. Important information about your donation receipt: The Ottawa Food Bank will issue a donation receipt for the fair market value of the shares based on the closing price of the security on the day the securities are received into the Ottawa Food Bank's brokerage account.
